FLUSH SYSTEM BEFORE CONNECTING GRAPPLE

The following steps will replenish the hydraulic lines with fresh oil and deliver any contaminants to the return filter on the machine. This procedure should be performed any time a new attachment is fitted on a machine.

1. Connect the open and close hoses together at the tip of the stick.
2. Run the open or close function for thirty (30) seconds in one direction.
3. Repeat steps 1 & 2 with the rotation hoses.

Additional steps should be taken when a failed hydraulic component is replaced on an attachment. In this case, the lines should be looped where they would normally attach to the failed component, such that the entire circuit is flushed back to tank before the replacement component is installed. If a failed component introduced metal contamination to the open-close system, both cylinders should also be disassembled and thoroughly cleaned to remove and accumulated contamination.

SYSTEM CONTAMINATION IS THE LEADING CAUSE OF COMPONENT FAILURE. MOST OIL IN THE GRAPPLE CIRCUIT DOES NOT CIRCULATE BACK TO THE TANK DURING REGULAR OPERATION.

LOAD HOLDING VALVES

- **This attachment is equipped with counterbalance type load holding valves to reduce the chance of undesired grapple leg movement in case of hose rupture, etc.**
- **Replacement with any load holding valves other than those approved by the factory will void the grapple warranty.**
- **The grapple should never be forced into the ground unless the legs are fully open and the “grapple open” function is held active.**
- **Never swing the grapple legs or the load being held by the grapple into a fixed object.**
- **This grapple was not designed for the removal of stumps (stump pulling).**
- **This grapple was not designed to assist in machine positioning. The heel rack may be used for this purpose.**

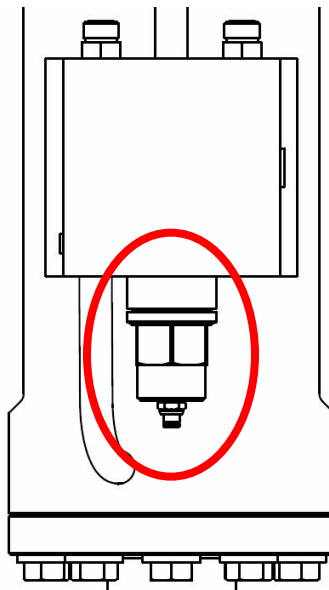

COUNTERBALANCE LOAD HOLDING VALVES

- Counterbalance valves will hold applied and induced pressures inside the grapple cylinders up to a set pressure limit.
- Fluid will relieve when this limit is exceeded.
- This is designed to prevent cylinder damage and mechanical failure.
- If the load exceeds the design limit of the grapple this system can cause undesired grapple leg movement which may result in loads being released.

TESTING HYDRAULIC OPEN/CLOSE CIRCUIT

T-MAR GRAPPLES - WHEN LEGS DRIFT DOWN FROM FULLY OPEN



NOTE FOR GRAPPLES UNDER WARRANTY: IF THIS TEST IDENTIFIES A FAILED COMPONENT, RECORD A VIDEO OF OIL FLOWING FROM THE HOSE OR FITTING

BRING MACHINE HYDRAULIC OIL UP TO OPERATING TEMPERATURE BEFORE STARTING TEST

1. FULLY OPEN GRAPPLE AND PLACE LEGS ON FIRM GROUND
 2. DISCONNECT "GRAPPLE CLOSE" HOSE FROM FITTING ON TOP OF SWIVEL [PORT 1]. CAP FITTING & PLUG HOSE
 2. DISCONNECT "GRAPPLE CLOSE" HOSES FROM GRAPPLE CYLINDERS, LEAVE CONNECTED TO SWIVEL
 3. LEAVE "GRAPPLE CLOSE" FITTINGS ON CYLINDERS UNCAPPED
 4. PULL "GRAPPLE CLOSE" HOSE ENDS OUT THROUGH SIDE DOORS AND SECURE ENDS INTO EMPTY PAILS
 5. CAREFULLY RUN GRAPPLE OPEN FUNCTION. **CAUTION:** A LARGE VOLUME OF HIGH PRESSURE OIL MAY EJECT FROM THE "GRAPPLE CLOSE" HOSES IF THE SWIVEL HAS FAILED. STAND CLEAR AND WEAR APPROPRIATE PPE
- IF OIL FLOWS INTO PAIL FROM GRAPPLE OPEN HOSES, SWIVEL WILL NEED TO BE REBUILT OR REPLACED
- IF OIL FLOWS OUT OF GRAPPLE CLOSE FITTING ON ONE OR BOTH OF THE CYLINDERS, CYLINDER IS BYPASSING INTERNALLY AND WILL NEED TO BE REBUILT OR REPLACED
- IF NO OIL FLOWS FROM OPEN HOSES & FITTINGS, PERFORM FOLLOWING TEST:
1. DISCONNECT "GRAPPLE OPEN" HOSE FROM FITTING ON TOP OF SWIVEL [PORT 2]. CAP FITTING & PLUG HOSE
 2. RECONNECT "GRAPPLE CLOSE" HOSES FROM SWIVEL TO GRAPPLE CYLINDERS
 3. LIFT THE GRAPPLE UP FROM THE GROUND WITH THE MACHINE
- IF LEGS DO NOT DRIFT DOWN, CHECK MACHINE CONTROL VALVE FOR OIL BYPASS
